Freedom of Information Act 2000 Request

Thank you for your Freedom of Information (FOI) request which we received on 9 January 2019 and I apologise for our delayed response.

The FOI Act gives you the right to know whether we hold the information you want and to have it communicated to you, subject to any exemptions which may apply. It is a public disclosure regime, not a private regime. This means that any information disclosed under the FOI Act by definition becomes available to the wider public.

Request

I would be grateful if you could provide me with the total volume of charged cases and the charging rate (proportion of cases charged) for rape flagged cases finalised in financial years 2013-14, 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19 broken down in the same way as your response to my previous FOI (7961)

for:

1) Available categories of rape flagged case (Total rape flagged cases, Rape only flagged cases, Rape and child abuse flagged cases, Rape and domestic abuse flagged cases, Rape, child abuse and domestic abuse cases)

AND

2) Available defendant age categories (10-13, 14-17, 18-24, 25-59, 60-69, 70-79, 80 plus)

Response

The CPS records data in relation to 'rape flagged' cases. The data does not constitute official statistics. The flag is applied to CPS files from the start of the case following an initial allegation of rape. This flag will remain in place even if the decision is taken to charge an offence other than rape, or where a rape charge is subsequently amended. The rape flag system is used by the CPS for case management purposes to ensure that the principles of the rape and sexual offence policy are considered throughout the life of all relevant cases.

'Child abuse' and 'domestic abuse' flags are also applied to relevant CPS files from the start of the case. It is important to note that these flags are applied to scenarios or circumstances that form part of the case rather than to specific charges.

The CPS holds charging data for the following categories of 'rape flagged case':

- 1) **Rape and child abuse** (cases featuring a 'rape' flag and 'child abuse' flag);
- 2) **Rape and domestic abuse** (cases featuring a 'rape' and 'domestic abuse' flag);
- 3) **Rape, child abuse and domestic abuse** (cases featuring a 'rape' flag, a 'child abuse' flag and a 'domestic abuse' flag);
- 4) **Rape only** (cases which only feature a 'rape' flag);
- 5) **Total rape** (all rape-flagged cases combined. This is the data set that is published in the annual VAWG report, the most recent version of which can be accessed [here](#)).

In the tables provided in the enclosed attachment, the charging data requested has been broken down by the available defendant age categories (10-13, 14-17, 18-24, 25-59, 60-69, 70-79 and 80 plus).

Please note that the data provided for 2018-19 only covers the first two quarters of the financial year (1 April 2018 – 30th September 2018).

Volume of live rape-flagged cases under investigation

Rape investigations are becoming increasingly complex and charging decisions now take longer to complete for a number of reasons including the need for the police to collect and prosecutors to review increasing volumes of material from mobile phones and other electronic devices. In November 2018, 2535 live rape-flagged cases were either sitting with the CPS for review and consideration of charge or with the police following receipt of an action plan. The volume of current work in hand has contributed to the falls in the volume of rape-flagged cases charged.

Falling volume and proportion of rape-flagged cases resulting in no further action

You will note that the tables we have provided also include CPS data in relation to the number and proportion of rape-flagged cases where the CPS prosecutor advised no further action following consideration of the available evidence. The total number and proportion of rape-flagged cases resulting in a no further action decision fell between 2015-16 and 2017-18.

Increased number and proportion of 'administratively finalised' cases and impact on charge rate

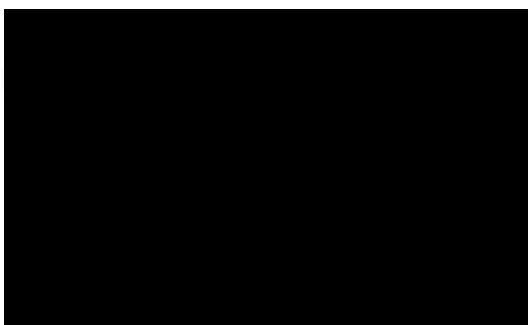
You will note that the tables we have provided also include CPS data in relation to the number and proportion of rape-flagged cases that were administratively finalised by the CPS across the relevant time periods. The use of Early Investigative Advice is increasing. This means that more cases are being returned to the police for further investigation before a charging decision is made.

Cases are administratively finalised where the police have not responded to an action plan or where the police have decided not to pursue the investigation following early advice from

prosecutors. A case which is administratively finalised will not always be at an end. A case may be re-opened at a later date should more evidence become available following a police response to an action.

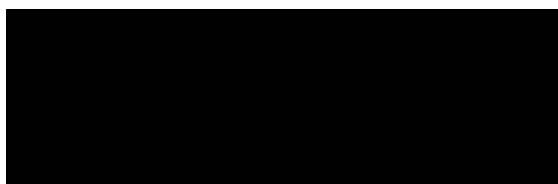
The volume and proportion of rape-flagged cases administratively finalised by the CPS increased every year until the end of 2017-18. In the first two quarters of 2018/19 the proportion of rape-flagged cases administratively finalised by the CPS increased. These trends have served to magnify the scale of the fall in the charge rate and we have provided a column in the attached tables entitled 'charge rate excluding admin finalised' which removes administratively finalised cases from the charging rate calculation.

If you are not satisfied with this response you have the right to request an internal review by responding in writing to one of the addresses below within two months of the date of this response. The internal review will be handled by a member of CPS staff who has not been involved with your original request.



You do have the right to ask the Information Commissioner's Office (ICO) to investigate any aspect of your complaint. However, please note that the ICO is likely to expect internal complaints procedures to have been exhausted before beginning their investigation.
